OFFICE ORDER

It is being notified for all concerned that as resolved from the meeting of the Academic Council held on 19.4.2021 the following are being adopted for implementation:

1. The credit mobility of the SWAYAM based online courses shall be based on the UGC Gazette notification No.F. 1-100/2016(MOOCs/e-content) dated New Delhi, the 25h March, 2021.
 - (i) Further in many programs, there are courses being offered through Massive Open Online Courses (MOOCs) from different online platforms where there are no clear directives for assessment of the courses offered through MOOCs platforms. Considering the fact, the following assessment strategy is to be adopted for the courses offered through MOOCs platforms:
 - (a) There would be assessment of 100 marks for all courses offered through MOOCs platform
 - (b) 100% marks would be taken from the assessment done by the MOOCs platform and certificate issued by the MOOCs platform
 - (c) One faculty in-charge/ coordinator need to be allotted against each courses offered through MOOCs platforms to monitor progress and upload marks and certificates in the examination portal
 - (d) If the results of the MOOCs platform are not declared till publication of result by the university, Incomplete (I) grade would be awarded and that would be updated as and when the assessment of MOOCs platform is available
 - (e) For unsuccessful cases, the candidate would again enroll in the MOOCs platform in the subsequent session to upgrade performance.
 - (f) If the course is discontinued / transferred as audit course by the MOOCs platform, new equivalent course would be offered by the BoS/DC (Departmental Committee) for the unsuccessful / back paper candidates and in such cases students would be assessed afresh
 - (g) In case, the credit points are not mentioned/awarded by the offering MOOCs platform, equivalent credit points to be defined before offering the course by the BoS/DC based on basic guideline available in this respect

2. In many programs, audit / non credit courses are recommended in the curriculum where the assessments for the courses are not well defined. In that case the following are to be adopted for assessment of the audit/ non credit courses:
- (h) There will not be any end semester examinations for the audit courses
 - (i) Attendance in the courses (as applicable for online/offline/MOOCs etc) would be counted for eligibility to pass the course
 - (j) Assessment would be done on the basis of continuous and final assessment as may be decided by BoS/DC (Departmental Committee)
 - (k) The qualifying criterion would be 40% marks as per other courses
 - (l) In mark sheet/grade card, it would be mentioned as “Qualified (Q)” or “Not Qualified (NQ)”
 - (m) For “Not Qualified” cases, the student would be assessed in the next academic year, if they students want to upgrade to “Qualified” category.
