

8. Student feedback mechanism on Institutional Governance / Faculty performance

- 1. Written feedback forms are taken from students and feedback is also taken from websites.
- 2. Feedbacks are taken on different parameters.
- 3. The Feedbacks are then analyzed to get the final performance of the faculty.
- 4. For the faculty whose feedback is found to be less than 3 out of 5, counseling is given by the respective Head of the Departments.

9. Grievance redressal mechanism for faculty, staff and students

The purpose of this procedure is to establish a process for students to express and resolve misunderstandings, concerns, or grievances they have with any college employee in a prompt, fair and equitable manner. This procedure emphasizes an informal resolution.

- 1. To protect each student's freedom of expression in the classroom
- 2. To protect each student from prejudice or arbitrary and capricious academic evaluation as evidenced by the student's final course grade.
- 3. To protect each student against improper disclosure of the student's views, beliefs and political associations.
- 4. To protect a student's right to a learning environment that is free from unlawful discrimination.

Withdrawal of grievance

At any time during the grievance procedure the student may withdraw the grievance.

Time limits on filing a grievance

A student must file a grievance by the last day of the academic semester following the action that gives rise to the grievance. Principal may suspend this rule under

exceptional circumstances. All grievance records will be held in the Office of the Convener for a period of one year.
